Poland, officially the republic of Poland, is a country located in central Europe, With its capital Warsaw being the largest city.



Poland is on the central European time zone (GMT+1 hour/UTC +1Hour)



Poland's economy is considered one of the fastest growing economies in Europe.



The climate is mostly temperate throughout the country. Winter (December- March) is usually relatively cold, hot summers usually run from June-August.

Official language: Polish






Poland: Europe's new university destination?






- Polish university education system has a history of 650 years of educating high profile professionals.

 - Lots of business possibilities and business partners.




Poland needs workers to compensate labour shortage

- According to the Ministry of Labour, Poland could lose up to 1,35 million of workers, or 10% of an employable population, before 2020.

Poland is an affordable European country with a stable economy.



Living Cost for international student varies between 250 – 450 EUR/Month. This varies from one city to another and according to a students lifestyle.



International students can find accommodation in university residence halls or private rental apartments.



Student residence halls cost between 60-150 EUR/Month, but conditions vary from one residence hall to another.



Private rental apartments costs between 80-160 EUROS/month for shared flats. For private apartments they cost between 300-465 EUR/month in big cities like Krakow and 350-650 EUR/month in Warsaw, the capital city of Poland.





Other basic utilities like, electricity, water, waste disposal cost around 155EUR/month for an 85 square meter apartment.



Food usually cost between 100-150 EUR/month, this also varies from one student to another.



Averagely, meals in most restaurants cost only 5 EUR, and 23 EUR for a 3 course meal for two.



Transportation in Poland is very affordable. Most students pay for a semester pass, which costs between 45 -50 EUR for the duration of the semester.



Study materials (books, texts books and research magazines) in most cases can be purchased from the university. However, they can be purchased from local book stores with used products to save cost.



Work while studying & after graduation

- Both foreign and local students are permitted to work during their study period in Poland.
- International students and Non-EU students are expected to poses a valid residency permit.
- Students are only allowed to work part-time(without limit number of hours) during a session, and work for full time during the holidays (usually 3months).
- Only those with resident card holders are permitted to work full time.
- Students from other EU countries are allowed without restrictions after graduation.
- International and Non-EU students are permitted to stay back for 2-3 years after graduation, as long as they show proof of financial independence without government support.
